Formal papers for the New Farm Nash Theatre Inc. AGM



Anyone can attend the Meeting; attendees should note and act on the following:

- 1. **Participation in the Meeting:** All persons who wish to play an active part in the Meeting, whether by merely contributing to the discussions, or by voting, submitting a proxy vote, standing for Committee or nominating or seconding someone for the Committee, must be financial at the commencement of the Meeting;
- 2. **Nominations** are required to be in writing and signed by the Nominee, Proposer and Seconder, all of whom must be financial at that time, and should be lodged with the Secretary fourteen (14) days before the meeting (i.e. by Sunday 22 November 2015). The Secretary will post a list of all candidates' names in alphabetical order, with the proposers' and seconders' names, on the Notice Board in the Play Shed at least seven (7) days before the Meeting, i.e. by Sunday 29 November 2015, at the latest. These written nominations shall take precedence over any subsequent nominations from the floor of the Meeting, should they be required..
- 3. **Apology and Proxy:** Any member who is unable to attend is requested to advise the Secretary with an apology and nominate another person, or the Chairman of the Meeting, to be their Proxy for voting purposes. Formal Proxy votes count as attendances in respect of achieving of a quorum.
- 4. Formal Motions: If any Member has a matter that they wish to be formally discussed at the Meeting they should submit a formal Notice of Motion to the Secretary, with the name and signature of a Seconder, preferably not less than seven (7) days before the Meeting. On receipt of a valid Motion, the Secretary shall post a copy of the Motion on the Notice Board prior to the Meeting. The Motion will then become a substantive addition to the Agenda and the resolution of the Motion (as possibly amended) by the Meeting shall be binding on the incoming Committee of Management.
- 5. **Financial Status:** The Membership Secretary will shortly be sending out reminders to all Members whose membership is about to lapse or has already lapsed (within the current calendar year). Renewal of membership can be done by cash or cheque payment directly to the Treasurer or electronically (EFT) to New Farm Nash Theatre Inc. at the CBA Milton Qld, BSB 064 123; Account No. 01007 1198. If anyone is uncertain of their status they may contact the Treasurer directly (usual details).
- 6. Deferred Meeting: If it is not possible to achieve a quorum within 30 minutes of convening the Meeting on 6 December 2015, the Management Committee has determined that the Deferred AGM will be held at the same time and in the same place on Sunday 13 December 2015. At that time, the number of financial members present at the convening of the Deferred Meeting shall be the quorum.
